Metaldehyde

The picture looks slightly different for each water treatment works/catchment.

Pitsford

High concentrations of Metaldehyde continued into 2013 with notable peaks recorded in the Scaldwell Brook and Walgrave Brook in May. The reservoir remains above the drinking water standard but concentrations are declining slowly.

Ravensthorpe and Hollowell


Feeder streams back to acceptable levels but the reservoirs' concentrations although declining remains above the 0.1 ug/l level.

Wansford abstraction to Rutland

Summer concentrations of Metaldehyde are generally hovering just above and below the standard.

Nene Catchment Abstractions: Metaldehyde in Raw Water Update


Pitsford Reservoir - Metaldehyde in Raw Water




CATCHMENT SENSITIVE FARMING
